

PRIVACY POLICY

This Privacy Policy provides information about Mohegan/PV, LLC's and its subsidiaries' d.b.a. Pasta Vita's policies with regard to personal information. This policy covers our survey site ("Site"), mobile applications, loyalty program, and related services (collectively the "Services") to our users ("User", "Users", "you", "your"). Your access to and use of the Services is subject to Pasta Vita's Terms of Services which you can find at www.pastavita.com.

This Privacy Policy will explain what personally identifiable information ("Personal Information") and other information is collected from Users of the Services, how it is use and with whom it is shared.

By voluntarily providing us with Personal Information, you are consenting to our use of it in accordance with this Privacy Policy. If you provide Personal Information in relation to the Services, you acknowledge and agree that such Personal Information may be transferred from your current location to Pasta Vita's offices and servers and to any authorized third parties referred to herein.

What information does Pasta Vita Collect?

We receive and store any information you enter on the Site, successor websites, loyalty application or any other Services we offer, or information you give us in any other way, including information you send us via mail, email, telephone, SMS, and social media operated by Pasta Vita. While participating in the Services, you may be required to provide personal information such as your first and last name, phone number, mailing address and email address.

Your information also includes information you choose to share on the Site, or other Services, including but not limited to photos of you, social media profiles, and the information you provide to us. We also receive non-identifying information such as the time, date, and location you use our Services, and the time, date, and location you took photos or videos or visited locations.

We receive and store certain types of automatic information whenever you interact with us. Like many websites, we use "cookies," and we obtain certain types of information when your Web browser accesses the Field Agent Site. You can instruct your browser, by editing its options, to stop accepting cookies or to prompt you before accepting a cookie from the website visit.

We may also automatically collect certain information when you provide information such as

your location/GPS coordinates (if you enable this feature), a device identifier (but not the UDID), MAC address, and wireless service provider. You can enable or disable location services through your mobile device settings. This location information is not treated as personal information unless we combine it with or link it to any of the personally identifiable information mentioned above.

What communications may I receive from Pasta Vita?

By entering the survey or registering for the loyalty program or otherwise using the Services with Pasta Vita, you will receive communications from Pasta Vita about projects, operational information, status updates, transaction updates promotional offers and other information relevant to your participation and use of the Site and other Services. These communications will be delivered via phone, direct mail, email, push notification, and/or SMS. You may opt out of these communications via email.

How will Pasta Vita use my information?

Pasta Vita collects and uses your personal information to enter you into the drawing, communicate to you about the loyalty program and other Services, process your transactions, provide service and support, respond to Requests, respond to inquiries, improve our information regarding demographics and metrics, resolve dispute and/or trouble shoot, display information that is customized to your account, and improve the quality of the Site, loyalty program, and the Services.

We may also use your Personal Information to create Anonymous Information records by excluding information that makes the information personally identifiable to you.

Does Pasta Vita Share the Personal Information It Receives?

Except as set out in this Privacy Policy, Pasta Vita does not disclose or sell your person information to any third parties.

We may disclose certain personal information, including:

- to third party vendors who help us provide the Site or Services;
- to Pasta Vita Clients;
- to third parties to whom you ask us to send personal information;
- to a parent company, subsidiaries, joint ventures, or other companies under a common

control (collectively, "Affiliates"), in which case we will require our Affiliates to honor this Privacy Policy; to a company that merges with us, acquires us, or purchases our assets (including in bankruptcy), in which case such company may continue to process your personal information as set forth in this Privacy Policy; or

- If we believe in good faith that such disclosure is necessary to (a) resolve disputes, investigate problems, or enforce our EULA; (b) comply with relevant laws or respond to requests from law enforcement or other government officials relating to investigations or alleged illegal activity, in which case we can (you authorize us to) disclose Personal Information without subpoenas or warrants served on us; or (c) protect and defend our rights or property or the rights and property of you or third parties.

Anonymous Information:

We reserve the right to disclose Anonymous Information without restriction, including to third party vendors who may help us enhance or provide the Service.

How do I change or review certain Information?

You can review and/or change certain of your Personal Information through the Service. You authorize us to use and disclose any new or modified information that you provide in accordance with this Privacy Policy, and you agree that we are under no obligation to delete or modify information that you have previously chosen to provide us. Please remember that if we have already disclosed some of your Personal Information to third parties, we cannot access that Personal Information any longer and cannot force the deletion or modification of any such information by the parties to whom we have made those disclosures.

You can close your Account by contacting us with a request that we delete your account information. We will take action to delete your information as soon as we deem practicable, but we may retain certain Personal Information to comply with laws, prevent fraud, resolve disputes, troubleshoot problems, assist with any investigations, and otherwise as permitted by law.

Disputes:

If you choose to use our Services, any dispute over privacy is subject to this Privacy Policy, our Terms of Service, including limitations on damages, arbitration of disputes, and application of the law of the state of **Connecticut**. If you have any concern about privacy at Pasta Vita, please

contact us with a thorough description, and we will try to resolve it.

Links to Other Web Sites:

This Privacy Policy applies only to the Services. The Services may contain links to other sites not operated or controlled by Pasta Vita (the “Third Party Sites”). The policies and procedures we described here do not apply to the Third Party Sites. The links from the Services do not imply that Pasta Vita endorses or has reviewed the Third Party Sites. We suggest contacting those sites directly for information on their privacy policies.

Security:

We take precautions designed to protect your Personal Information provided via the Services from loss, misuse, and unauthorized access, disclosure, alteration, or destruction. While we use encryption to protect sensitive information transmitted online, no Internet email transmission is ever fully secure or error free. In particular, email sent to or from the Services may not be secure. Therefore, you should take special care in deciding what information you send to us via email. Please keep this in mind when disclosing any Personal Information to Pasta Vita via the Internet. We also protect your information offline. Only personnel who need the information to perform a specific job function (such as mailing you materials, contacting you about a Project, or processing a Payment) are granted access to your personally identifiable information. The computers/servers in which we store personally identifiable information are kept in a reasonably secure environment.

Children:

Pasta Vita does not knowingly collect Personal Information from children under the age of 13. In fact, as per the Terms of Service, you must be 18 to use the Services.

Changes to Pasta Vita's Privacy Policy:

The Services and our business may change from time to time. As a result, at times it may be necessary for Pasta Vita to make changes to this Privacy Policy. Pasta Vita reserves the right to update or modify this Privacy Policy at any time and from time to time without prior notice. Please review this policy periodically, and especially before you provide any Personal Information. Your continued use of the Services after any changes or revisions to this Privacy Policy shall indicate your agreement with the terms of such revised Privacy Policy.
